Submit Official Transcripts

New applicants to undergraduate programs must submit official transcripts from all institutions. This includes high school and all previous post-secondary institutions. Faxed, scanned or photocopied documents are not considered official. Transcripts become the property of Vancouver Island University and will not be returned. The only exception is where a transcript is deemed to be irreplaceable. If submitting such a document, please request its return at the time of submission.

Current high school students from BC and the Yukon must provide their Personal Education Number (PEN) and may also be required to submit an interim transcript for admission purposes.

New applicants to graduate programs must submit official transcripts from all previous post-secondary institutions. High school transcripts are not required from applicants to graduate programs.

What Happens Next?

Within two weeks of receiving your application, Vancouver Island University will mail you a letter confirming receipt of your application. Please read our letters carefully and call if you have any questions.

If you are admitted to a program, an offer of admission will be mailed to you. A non-refundable, non-transferable deposit (usually \$200) will be required to confirm your acceptance of the offer of admission. The due date to accept the offer and pay the deposit will be outlined in the letter of acceptance.

The University considers it to be sufficient notification to mail information to the student's address on file; however, we may also contact you by telephone or email. Please call the Registration Centre to notify us of changes to your contact information.
